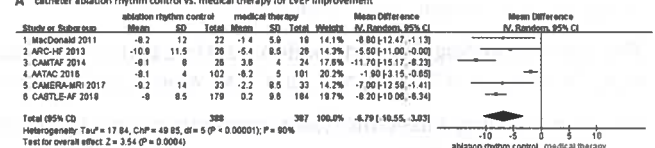

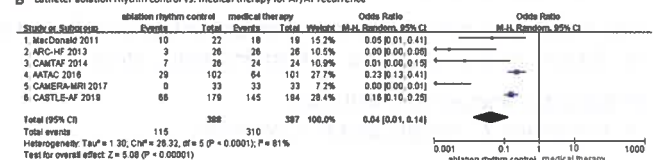

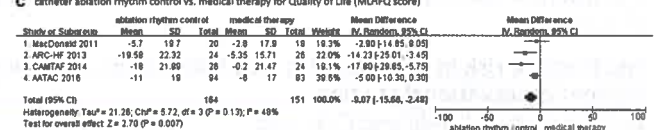
A catheter ablation rhythm control vs. medical therapy for LVEF improvement

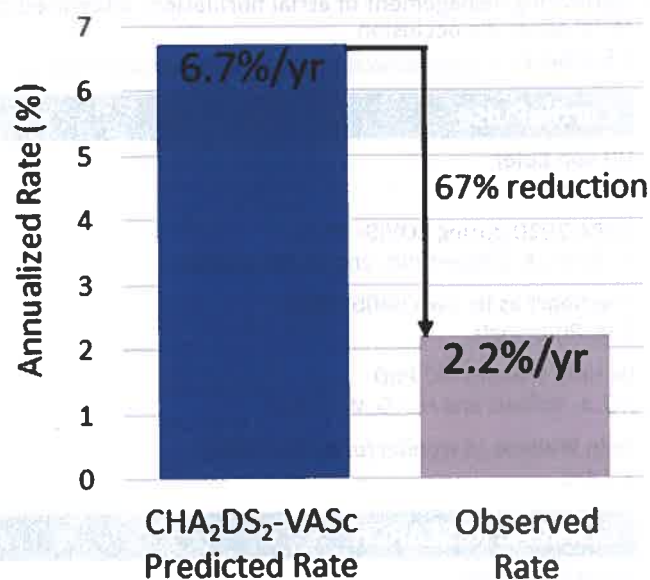
