David Drachman passed away on December 5, 2016. He was an exceptional leader in neurology, and one of our most valued reviewers, often serving to help with final decisions when other reviewers provided discordant comments. He was the ombudsman for the journals. With his passing, we have asked David Knopman to assume that role, and he has agreed. Dr. Knopman served as an associate editor and deputy editor of the journal; other duties prompted his stepping down from the latter position, but he has remained on the Editorial Board. The journals will still have the benefit of his detailed knowledge of our processes, and his well-calibrated sense of what's right, if there are concerns about the handling of a manuscript. In the rare event that there are concerns about a manuscript for which Dr. Knopman has a conflict, the editor-in-chief will appoint an ad hoc ombudsman.
